Ken Yoder had a problem with his thumb. Rumor has it that someone hit him in the nose. Get it? Kind of sick, huh.



## Instructions For Treating Yule Tree Are Listed

The proper solution for treating Christmas trees to reduce the danger of fire has been noted by the Goshen Fire Department.

The solution consists of nine ounces borax, four ounces boric acid, one gallon of water and a half-teaspoon of low sudsing detergent. These ingredients are to be mixed thoroughly and the tree greens should be saturated with it.

The base of the tree is then to be placed in the solution so that it can absorb it. The tree and greens are to be allowed to dry thoroughly before decorating.

The fire department also noted that the solution is not harmful to livestock.

We want to thank each of you for your prayers, concern, cards, visits and encouragement during this time. I am very grateful to work for a company that cares enough to hold a special prayer meeting for our son.

There is no doubt in our minds that this was anything less than a miracle. God answers prayers as much today as ever. We thank the Lord every day for what He has done in Kenny's young life.

**Will Your Itemized Deductions Flag Your Personal Tax Return for Audit?**

It pays to be "average"—at least so far as your tax return is concerned. *Reason:* An above-average return is like a "red flag" and, as such, it catches the eye of everyone—including that of the IRS computers.

**What's an average return?** It's one in which the amount of itemized deductions claimed approximates the average amount claimed by other taxpayers in the same income bracket. To check whether you're average, take a look at our following table. It's based on figures for 1972 (the latest released by the Revenue Service).

►►►**IMPORTANT→** Just because your deductions compare favorably with these averages, don't think you can't be audited. You most certainly can be. Also, if you have extraordinary deductions, never pass them up just because they throw you above the average. However, you should make certain that you can prove them—as well as all other items in your return.



The dove-tails run obliquely, and parallel, thus:—



If the walls and the ceiling of the room could be taken and laid out flat they would look something like this:—




The second path length is then




# This Issue's Problems
