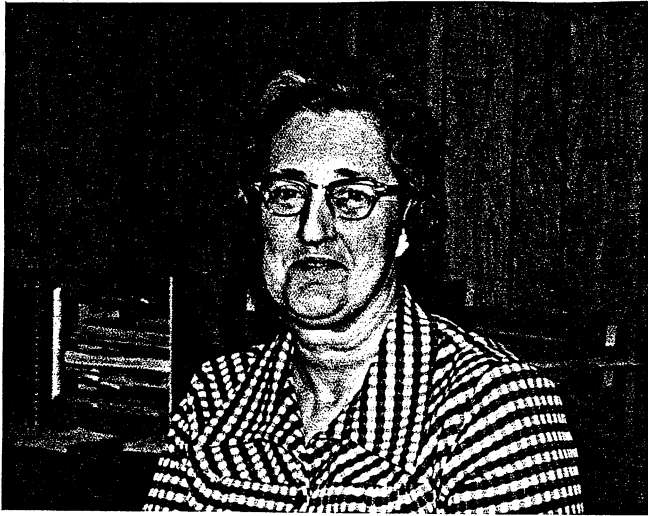

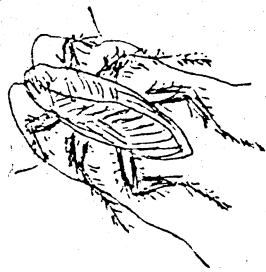

Ken served for several months on the Employee Council. Last year he enjoyed participating on the CROWN team in the WCMR Marathon.

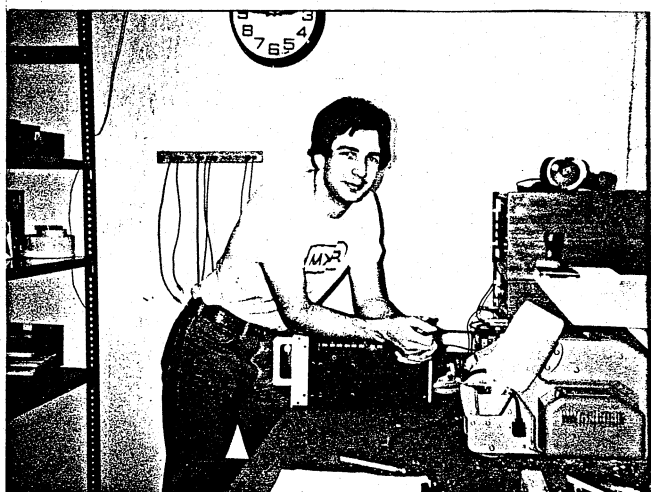

Drew enjoys soccer, running, music and meeting people. He plays the guitar and sings with a local gospel group called "All God's Children".

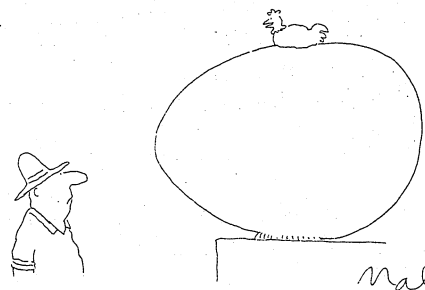
One of his goals here at CROWN is to win a ping-pong game. Well, we can't promise that you'll win soon, but best of luck in the game and at CROWN.

## On the Other Hand



Before you get your vacation all planned for the summer, please think about the following. A vacation will not lead you to relax, refresh yourself, or get away from anything, let alone everything. The situation is this: a vacation takes you away from a routine and relatively well understood situation to one that is largely new and unpredictable. The beach, the mountains, the lake, the desert, the LaBrea Tarpits -- are all the same. When you leave home you're out of your element and into someone else's. You will have to tackle new and frequently unexpected set of difficulties.

To go into deeper (and uglier) detail, the following "perfect example" is instructive (and please understand that perfection is no easy thing to achieve in vacations). You've encountered the "Theme Park" approach. "Ream Park" is more descriptive. Walt Disney started it innocently enough. His imitators and the disciples of P.T. Barnum have carried on in grand style. In a typical theme park -- let's make one up called, "Three Flags

Over Disney Island", your first challenge is getting there, which, after all, is half the fun. Hitchhiking will beat every other way by a large margin. Walking or bicycling comes next. Whatever you do keep clear of gas stations and parking lots.

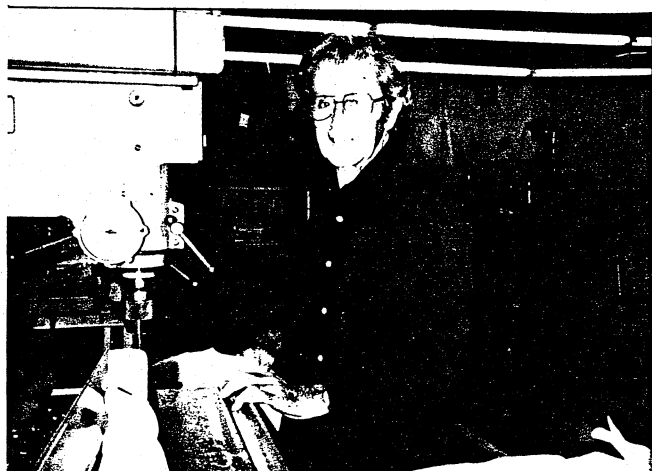
You get through the gate by throwing a pile of greenbacks to the gateperson. It is widely believed that by paying only once you save money because you don't have to pay for individual rides once inside. This economy evaporates after the first ride makes you too sick to participate further. The rides are designed to destroy adults' sense of equilibrium and prevent them from taking further rides so that the kids can do the riding. The kids do not get sick, love to be terrorized, and will drag their parents back at a later date. The line theory also works to the advantage of the park. By keeping the lines long, adults are discouraged to a greater degree than kids. Past a certain age, the benefits of standing in a slow-moving line of rowdy children for 45 minutes (just to get sick) become unclear. Below that age, the thrill of the ride is worth it all. The moral of the story is clear -- never take a vacation unless you do not need one. If you need one, the risk that the vacation will push you over the edge is too great. If you don't need one, go right ahead -- you probably have the strength to stand it.

but loving because you love.

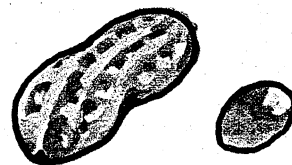
When you love others,

No one knows how or why many of these wacky laws were enacted. But whatever the reasons, they make for hilarious reading.



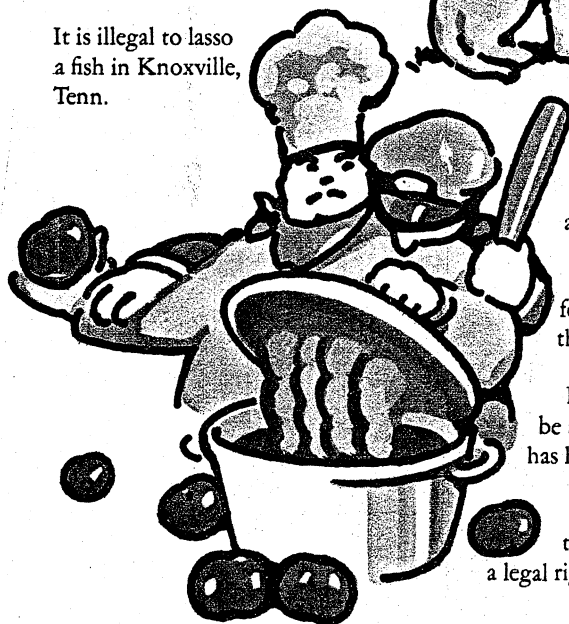
A Louisiana law upholds your right to grow as tall as you like.

In Denver, Colo., the law insists that dogcatchers notify dogs of impounding by posting a notice on a tree in the park.

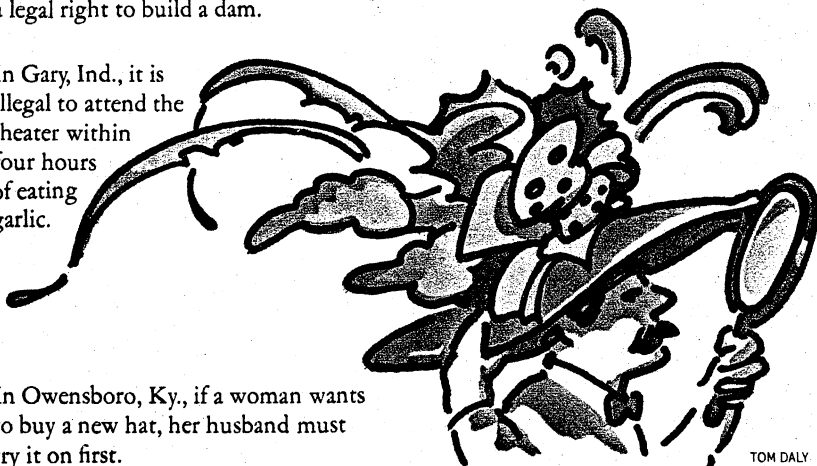
The law forbids women in Oxford, Ohio, to undress in front of the photograph of a man.

In Connecticut, the law states that if you are a beaver, you have a legal right to build a dam.

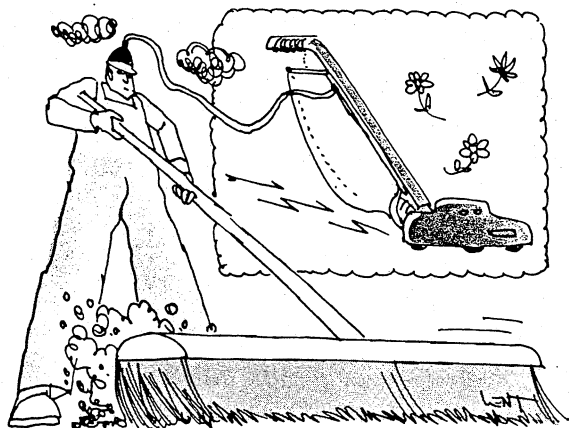
In Gary, Ind., it is illegal to attend the theater within four hours of eating garlic.

In Owensboro, Ky., if a woman wants to buy a new hat, her husband must try it on first.



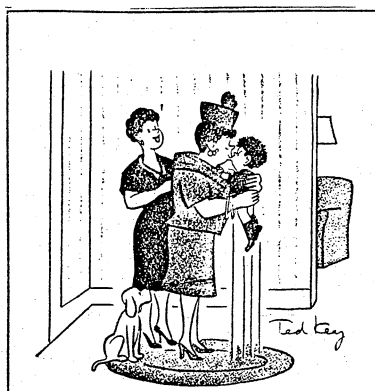

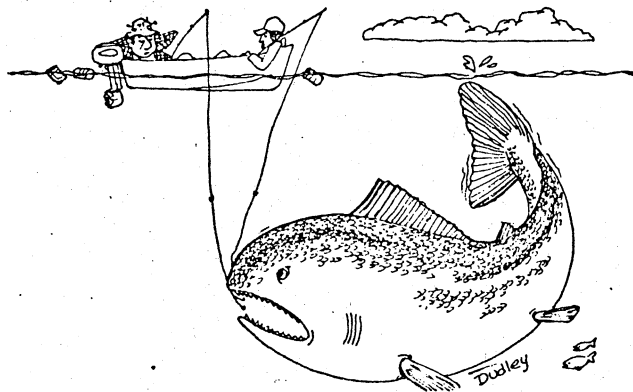
### The Origin of Father's Day

A number of people have been a part of the growth of Father's Day as an American holiday. The most influential was Mrs. John Bruce Dodd of Spokane, Washington, who first proposed the idea in 1909. The mayor of Spokane issued a proclamation setting aside June 19, 1910, as the date for the celebration. The governor of the state announced that the occasion would be celebrated throughout the state.

The newspapers carried stories and articles about the Spokane observance, and interest in Father's Day increased. It was not formally recognized, however, until 1972, when a Congressional resolution set aside the third Sunday in June as the permanent date for the celebration. Long before that time, however, Father's Day had become an occasion for giving gifts and extending warm greetings to relatives and friends.

#### Additional Clues

**General:** Each title provides a clue of sorts. High frequency letters are E, T, O, A, N, I. The three types of codes used on this page are: (1) Alphabet shift, in which cipher letters and plaintext letters are a uniform number of letters apart (as in the title of this page); (2) Reverse alphabet, in which substitutions are reciprocal—that is, if A = J, then J = A, etc.; and (3) Keyed cipher, constructed around a key word or phrase relating to the theme of the cryptogram. In a keyed cipher, if you print the cipher alphabet above the plaintext alphabet, the key word will appear plainly in the ciphertext. All remaining letters will follow the key word in alphabetical order. An example of a keyed cipher using GAMES as the key word would be:

Ciphertext: RTUVWXYZGAMESBCDFHIJKLNO  
Plaintext: ABCDEFGHIJKLMNOPQRSTUVWXYZ

## STRAWBERRY CREAM PIE

| 1 - 9 inch baked pastry shell  | 1/2 C slivered blanched almonds,<br>(toasted) |
| 1 recipe Cream Filling (below) | 2 1/2 C fresh strawberries                    |
| 1/2 C water                    | 1/4 C sugar                                   |
| 2 tsp cornstarch               | Few drops red food coloring                   |

Cover bottom of pastry shell with nuts. Fill with chilled Cream Filling. Halve 2 cups of strawberries. Pile atop filling.

GLAZE: Crush remaining 1/2 C berries; add water; cook 2 minutes; sieve. Mix sugar and cornstarch; gradually stir in berry juice. Cook, and stir till thick and clear. Tint to desired color with food coloring. Cool slightly; pour over halved strawberries. Keep refrigerated till serving time. Pass whipped cream, if desired;

## CREAM FILLING FOR PIE ABOVE

| 1/2 C sugar                | 3 T cornstarch        |
| 3 T flour                  | 1/2 tsp salt          |
| 2 C milk                   | 1 slightly beaten egg |

Mix first 4 ingredients. Gradually stir in milk. Stirring constantly, bring to a boil; reduce heat and cook and stir till thick. Stir a little of hot mixture into egg; return to remaining hot mixture. Bring just to boiling, stirring constantly. Cool, then chill. Beat well; fold in whipped cream and vanilla.

## STRAWBERRY-RHUBARB BARS

| 1 3/4 C all-purpose flour     | 2 T powdered sugar       |
| 1/2 C butter or margarine     |                          |
| 1 1/2 C granulated sugar      | 1/4 C all-purpose flour  |
| 1/4 tsp salt                  | 6 egg yolks              |
| 1 C whipping cream            | 4 C sliced fresh rhubarb |
| 1 C sliced fresh strawberries | 1/2 tsp lemon juice      |
| 6 egg whites                  | 1/2 C granulated sugar   |

Heat oven to 350°

1. Mix 1 3/4 cups flour and the powdered sugar in medium-size bowl. Cut in butter until mixture resembles coarse crumbs. Press mixture into greased 13x9x2-inch baking pan. Bake until golden, 10 to 12 minutes.

2. Mix 1 1/2 C granulated sugar, 1/4 C flour and the salt in large bowl. Lightly beat egg yolks; stir egg yolks and cream into sugar mixture. Stir in rhubarb, strawberries and lemon juice. Spread mixture evenly over crust. Bake until firm, about 1 hour.

3. Beat egg whites in large mixer bowl until foamy; beat in 1/2 C granulated sugar, 1 T at a time until stiff peaks form. Spread over rhubarb mixture. Bake until light brown, 10 to 15 minutes. Cool in pan on wire rack. Cut into squares.

## STRAWBERRY ICE CREAM

- |                                |                   |
|--------------------------------|-------------------|
| 1 envelope unflavored gelatin  | 1/4 C cold water  |
| 2 well-beaten egg yolks        | 3/4 C sugar       |
| 1/4 tsp salt                   | 1 1/2 tsp vanilla |
| 2 C crushed fresh strawberries | 2 C heavy cream   |
| 2 egg whites                   | 1/4 C sugar       |

Soften gelatin in cold water; dissolve over hot water. Combine next 6 ingredients; add gelatin; mix well. Pour into 2-quart refrigerator tray; freeze firm.

Beat egg whites till soft peaks form; gradually add 1/4 C sugar, beating till stiff peaks form and sugar is dissolved.

Break frozen mixture in chunks; beat till fluffy with electric mixer. Fold in egg whites. Return quickly to cold tray; freeze firm.

Makes 8 to 10 servings.

2C graham cracker crumbs  
3 oz. semisweet chocolate pieces  
¼ tsp salt

1/2 C chopped walnuts

Start heating oven to 350° F. Place all ingredients in bowl; stir until blended. Turn into greased 8x8x2 pan. Bake 30 min. Cut into 2" squares while warm. Makes 16

## PEANUT BUTTER COOKIES - 43 CALORIES PER COOKIE

1/3 C sifted all purpose flour  
1/4 tsp baking powder  
2 T shortening  
1 T brown sugar  
1 egg, well beaten

1/4 tsp baking soda  
Dash salt  
2 T peanut butter  
1/2 tsp Sweet 'N Low (2 pkts.)


Start heating oven to 375° F. Grease cookie sheet very lightly; Sift together flour, baking soda, baking powder and salt; Work the shortening and peanut butter with spoon until creamy. Gradually add brown sugar, continuing to work until light; Add Sweet 'N Low and egg; beat well. Thoroughly mix in flour. Divide dough into 16 parts, dropping each by teaspoons onto cookie sheet; flatten with tines of fork. Bake 8 to 10 minutes or until done. Makes 16

In saucepan dissolve dry milk in 1½ C water; stir in tapioca, Sweet 'N Low, and 1/4 tsp salt. Let stand 5 minutes. Stir in egg yolks; bring to boiling, stirring constantly. Remove from heat (mixture will be thin); stir in vanilla. Beat egg whites to stiff peaks. Gradually fold into hot mixture. Chill. Spoon into dishes; sprinkle with ground nutmeg, if desired. Serves 6

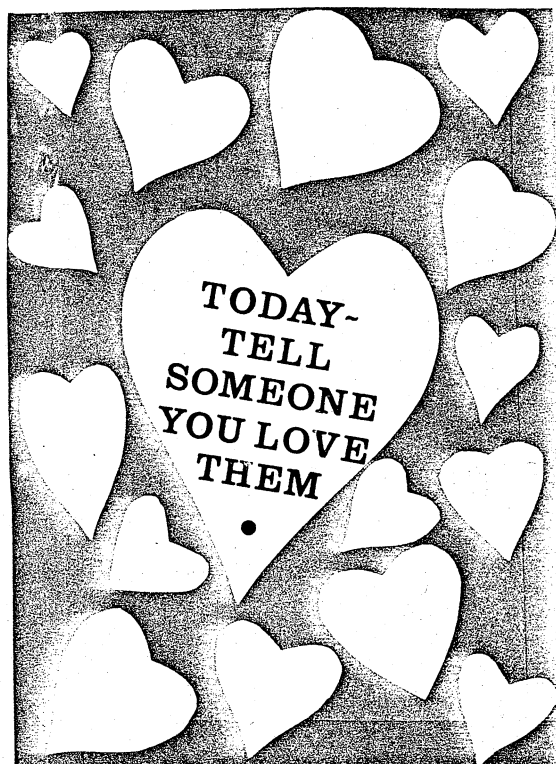

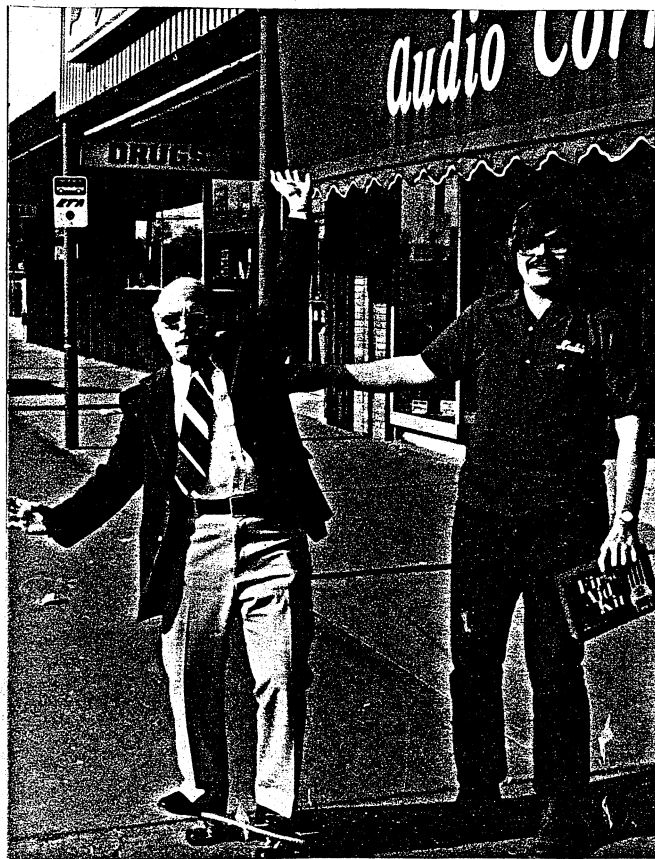
Let's meet Tim Bock.
